Re: Violations(s) of Mn Public Data Request, state statutes, civil rights, parental rights, u.s. codes, and more

**Dear Mr. Johnson;**

After organizing, cataloging, reviewing, and presenting all of our communication back and forth between you and our family with council and experts, We submit the following as part of our case file and encourage your immediate and complete cooperation so as to not put me in a position requiring me to exercise each and every remedy available to us and others in similar situations.

On **11 November, 2022** we submitted a public data request prescient to **Mn SS** which you acknowledged receipt of, and “said” you were going to comply with it and get the information requested. In reviewing all communications, it is apparent to me that you are, at best, non-compliant and stalling, in violation of not only our rights but in the state law as well. This will not be tolerated.

You have made assumptions and estimates about the volume of data requested in the public data requests, but you give nothing to back this up and “claim” a readiness date of “sometime in January”. You are hereby on notice that this has already been a month and unless you can more accurately articulate a reason for the delay AND a more definitive completion date, as required by law, then we are demanding and expecting that this information is ready for our review **no later than Tuesday 27 December 2022.**

This will be my last demand to bring you into immediate and complete compliance before exercising and exhausting all other rights and remedies available to me, as well as the publication of the issues at hand for public viewing.

Additionally – Your comments in your **30 November, 2022**, letter, that any conversations between myself, and/or my minor children and school representatives have been disruptive or worse are baseless, false, and without merit. Furthermore, you have no right nor authority to “create” a “rule” direct a parent of a student as to whom they can or cannot communicate with.

In closing, I expect that any further communication from you or anyone else on these matters be done in a respectful, truthful, and complete manner and will no longer tolerate delays. This will improve all of the shortcomings in communication between yourself, the two teachers, and myself.
